

Q4 - Connection to Green County. Please click on all that apply.




Q5 - I am directly connected to the following levels of government in Green County.




Q50 - In which watershed in Green County do you live or work? You can use the map above as a reference. Please select all that apply.


Q7 - How much do you currently know about the American Rescue Plan?

Q8 - Do you want to learn more about the American Rescue Plan?








Q11 - What time(s) would work best for you for an informational session?


Q13 - Do you think the entities should collaborate?




Q15 - Do you think the entities should partner together?





REAL stupid and largely meaningless survey. Sounds like a bunch of people put this together that are not living in the real world and will never actually accomplish anything concrete.

I would like to see the funding be used to invest in civic infrastructure - valued community assets that are often underfunded. Here is an article with supporting points/examples: Infrastructure That Does More: Investing in Public Spaces for a Resilient America (Bridget Marquis - November 25, 2020), published in Strong Towns: https://www.strongtowns.org/journal/2020/11/23/infrastructure-that-does-more-investing-in-public-spaces-for-a-resilient-america.

Funding should be distributed toward projects that would serve both immediate and future needs.

From my understanding of the funds need to be spent on projects that will not put a community and it's residents in a financial liability going forward. We should be looking at projects that benefit our community long term but will not demand future investments from tax payers.

Would love to see efforts focus on reinforcing and updated public entities such as libraries and parks and rec. These public buildings and infrastructures have been neglected, and it would be great to see efforts in coordinating county-wide updates (i.e., getting all libraries with solar power--a bulk project keeping the cost low across the etnire county because of the large project). Or other infrastructure like the sugar river watershed and new plumbing, supporting new expansions of buildings, or new water towers.

Use funds to build a new library in New Glarus. The current library is way too small and not ADA accessible.

This survey could have had more information up front before asking opinions. I really didn't know what to answer because wasn't very well informed.

Again, building a new and larger library for New Glarus is a major need!

When responding to Educational Informative sessions, I indicated I would attend in person, yet for format, I chose Zoom. That's easier to get to :-). I would attend in person if that was the only option.

Our communities have great resources in the people living in them. People want to make their communities better, but often lack of communication and/or lack of support make it difficult to contribute.

These decisions should be based on the needs of the area and what is the best for the community AND environment. It should not be somebodies "pet project" that isn't in the best interest of the majority.

I am the chair of Sylvester Township. Many residents in our township are greatly in need of broadband service. I am very interested in partnering with others to bring broadband to our township. From conversations I have had with our town residents, I know this is a priority for many of them. Some even consider this a greater priority than road maintenance.

Equitable as in across gender, economic and ethnic diversity? May need external guidance on that in Green County and other counties similar in current culture. Also in cultural, legal, political, business and projects seem based on who you know, not necessarily what is known or what the best might be. It's as if there's a closed box we all live in rather than a larger world.

I am hopeful there will be more creative thought and partnerships forged that speak to the sustainability and resiliency of our economic development with these funds. It will be sad to see communities relying on old methods (with arguably incomplete measures of community benefit), such as TIF creation. Let's broaden our definition of infrastructure to include creative supports such as solar for apartments or other workforce housing, energy efficiency for housing and the very small businesses on rural Main St. and of course, rural Internet. Also, I'd like to see things like electric car charging station development - especially those charging stations that come from local alternative energy. Etc...

Must educate and reward efforts to collaborate and partner. Again..... simply rewarding political clout stymies future efforts to collaborate and partner.

Respond to both the immediate health and economic impact of the pandemic but also use these unique resources for strategic planning of needs.

This is a great opportunity to focus on business development, affordable/low-income housing, and setting up Green County and its municipalities for the future!

The absolute top thing you can do with these funds is make high speed Internet available in rural areas. I do not have access to cable. I do not have access to fiber. I do not have access to DSL. Almost every day throughout the pandemic, I went into the office to work. With my home Internet connection, I cannot reliably work from home for any length period of time. This is nuts. High speed Internet is no longer an option, as the pandemic so pointedly demonstrated. It seems very appropriate to use these rescue funds to expand high speed Internet access.

I hope that in 5 years, the projects and/or programs invested in with ARPA funds have measurable positive outcomes for our communities, and are something we can be proud of for years to come.

There are two projects that I believe would benefit the City of Monroe: (1) A pocket park downtown with a public restroom. WI DNR as it has already given a small grant to the City for this purpose; Monroe Main St. also could lead a fundraiser for this project. (2) Install several vehicle charging units on the West Side parking lot; there will be a growing need for these units as electric vehicles become more prevalent in the not too distant future.

Build a new library in New Glarus

Feasibility of multiple community waste water treatment facility to perhaps reach a size that would be more efficient to operate and more effective to operate to meet environmental requirements going forward.

I live in the Village of New Glarus. This community has NO facility for the senior citizens to use to gather and offer programs. Many of us want to change that, but we have no funding sources. Along with this, our village has steady and growing use of our library facility, again with very little increase in funds and an ongoing effort to build a new facility. For over 20 years an active Library Board and ciitzens have tried and failed numerous times to find a suitable site to expand our teeny tiny pitiful facility. Pushback is constant as spaces in town are so limited. If we could have funding enough to build a facility to support both our new Library as well as include a community room this would be an investment far in to the future. This village is growing with new citizens and all ages and abilities could use this.

As a local official, I would be very interested to hear what other Towns/Villages/the County level is thinking of in terms of spending. As a Town, our largest expense is road construction — but it seems we will be unable to fund that via the ARPA. What options (if any) are there to use the ARPA to fill other buckets of our budget (Fire/EMS, elections, etc.) so that we can reallocate those freed up funds into our road construction budget?

None at this time.

I'm concerned that Towns won't be able to derive economic benefit from these funds as many of us don't have the services that the money is allowed to be used for.

Long term investments in eligible infrastructure (water, wastewater, etc.) should be a priority.

Our township is very hilly. I hope that the purchase and/or subsidy of hotspots for town residents to aid in broadband expansion will be a covered use of ARPA funds.
