2022 Committee concerns to County Fair & Goat Superintendents:

- Required Collars on the fairgrounds is unsafe for Boer goats with horns. Committee seeks clarification why they are required. Can Boer goats be an exception to the required collar in 2022? Sheep do <u>not</u> require collars.
- Meat goat auction Committee seeks written details on why not all 4-H kids can sell at the Green County fair. If there is a requirement of 10 or more meat goats then this needs to be announced and put in writing. If we reach the level of 10 participants then can everyone sell their goat? Green County Fair needs to start somewhere to begin growth of 4-H kids to show meat goats. If there is no opportunity, then the kids will not spend the time and effort to try meat goats. We need to start somewhere.

- Penning of goats as requested by members, every year, result in goats <u>not</u> being penned as requested by members, where large groups are put into small pens, when there is unused space in the barn. Goat committee requests this be resolved for the comfort and safety of the goats, fairgoers that like to see a barn being fully used and can see all the goats better, and the members receive satisfaction of getting what they request for their animals.
- Better fencing in the barn Goat Committee seeks ideas for raising money to obtain better fences
