- Request for extension of 4-H Travel Scholarship to new/existing members

- Discussion on whether or not to allow the extension/re-opening of the travel scholarship opportunity took place. An electronic pole was taken and the majority thought that the value of the travel experiences is worth extending the scholarship opportunity to as many members as possible even if they missed the deadline (new or existing 4-H members)
- Clarification as to whether or not Mini-Grants for Travel experiences are tied to the scholarship process (\$50per member per trip). Discussion came to an agreement that the two are indeed tied to each other. Motion by Emily, second by Mara; Motion passed.
- Colony Brands Donation of \$3,341.10 discussion as to how to distribute those funds. Members decided to present Adult Leaders with the proposal to put \$2400 towards the Club Mini grants (\$5/member), \$800 to Project Mini Grants, and \$141.10 to the Mini-Travel grants. Motion by Ann, seconded by Deb; motion passed.
