

# SHOOTING SPORTS LOCATION WAIVER AND RELEASE OF LIABILITY

## READ BEFORE SIGNING

The 4-H program partners with several different private locations to offer 4-H Shooting Sports programs. These locations including Blackhawk Sportsman's Range (South Wayne), Green County Rifle Range (Monroe), Allen Farm (Juda), and Darlington Gun Club (Darlington). In consideration of being allowed to participate in any way at the before mentioned locations, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury from shooting sports and other known and unknown events and activities and/or the use of the related building, structures, equipment, guns, pistols, land and all other real and personal property whether owned by shooting sports locations or others is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
2. I acknowledge and agree that the use of shooting sports equipment, guns, pistols, and other weapons by myself or others on location premises or otherwise are inherently dangerous and high-risk activities whether such equipment, firearms or weapons are discharged by myself or others; and
3. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS**, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** or others, and assume full responsibility for my participation; and,
4. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
5. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **HEREBY RELEASE AND HOLD HARMLESS** all shooting sports locations, its officers, directors, officials, agents, employees, volunteers, members, guests, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and lessors of real property and personal property used to conduct the events and activities ("RELEASEES"), **WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW.**

**I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND IT'S TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.**
