Greetings! Welcome to a new and exciting year planned for the Green County 4-H Shooting Sports Project! This mailing is to provide you more details about the opportunities we have to offer in each discipline, and the corresponding paperwork and fees.

If you wish to participate in any of the 4-H Shooting Sports disciplines, we encourage attending the 4-H Shooting Sports Kick-off Open House – **Thursday, January 2 from 5:30-7:00pm** at the Green County Justice Center, 2841 6th St, Monroe. Come anytime between 5:30-6:45pm to complete your permission and waiver forms (requires parent signature), pay project fees and ask questions about the disciplines.

For grade, age, & other eligibility requirements, read the individual discipline sections in the 4-H Shooting Sports newsletter.

NEW this year... 4-H .22 Rifle will move to an indoor range in Darlington for the clinic and county fair shoot. Also new this year, all 4-H Shooting Sports parents/guardians will need to sign a location waiver.

Youth who intend to participate in any of our 4-H Shooting Sports Clinics and Fair Shoots will need to submit at the Open House or to the Extension Office by the **Preferred Deadline of January 3, 2025:**

- 4-H Shooting Sports Permission Form
- 4-H Shooting Sports Project Fees Checks made payable to "Green County 4-H Adult Leaders"
 - .22 pistol, .22 rifle, air pistol, air rifle, archery, bb gun and muzzleloader = \$15 per shooter per discipline (not to exceed \$30 per family per discipline)
 - Shotgun is \$65 per shooter (not to exceed \$130 per family)
 - Master Shooters pay one fee of Gr. 3-4 \$35, Gr. 5-6 \$35, Gr. 7-8 \$100, and Gr. 9-13 \$100 (see Shooting Sports newsletter, page 2 for details)
- Location Waiver and Release of Liability form:
 - o Archery Discipline—Archery Club Waiver and Release of Liability
 - All Gun & Pistol Disciplines—Shooting Sports Locations Waiver and Release of Liability

This mailing includes a 4-H Shooting Sports Permission Form for each youth and 2024 4-H Shooting Sports newsletter, which contains rules and schedules for Green County 4-H Shooting Sports.
