As a condition for participation in the Green County Fair Meat Animal Auctions I agree to submit my animals for inspection by a veterinarian appointed by the Green County Fair Association and to have my animals submitted to any tests that may be designated by the veterinarian or buyer.

I hereby agree to sell animals only in the Green County Meat Animal Sale and will not sell animals at any other Fair Auctions in 2025. If found in violation of this rule, I understand I will forfeit eligibility to participate in future Green County Fair Meat Animal Auctions.

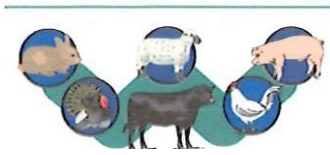
